Daniel Patrick Lennon, 34, of 5 McKinley St. Adams, died Tuesday, May 27, 2008, at his home.

He was born in North Adams on September 26, 1973, a son of David J. and Patricia A. (Kleiner) Lennon, and attended Cheshire Elementary School. He graduated from Hoosac Valley High School in 1992, and graduated with honors from the Surgical Technician Program at C.H. McCann Technical School in North Adams in 1993.

Mr. Lennon was the current owner and operator of Misty Moonlight Diner in Pittsfield, which he purchased in February of 1996. Earlier, he operated an entertainment business and would appear as Reggie the Clown, performing magic shows and entertainment for parties. He had also worked as a surgical technician at Berkshire Medical Center from 1993 until 1995.

He was a communicant of St. Stanislaus Kostka Church, Adams. He was a member of the Adams Lodge of Elks and the Cheshire Rod and Gun Club. He was an avid fan of the Boston Bruins, Boston Red Sox and New England Patriots, and enjoyed playing cards, target shooting, trips to the beach in Maine, and especially enjoyed spending time with his daughter.

Beside his parents, of Cheshire, he is survived by his wife, the former Bonnie L. Kordana, whom he married on June 19, 1999;

Memorial donations may be made to the Keira Lennon Educational Fund through the funeral home.

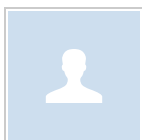
