



## Doreen St. Cyr Kozik

October 1, 1932 - February 6, 2009

Mrs. Doreen (Holt) St. Cyr Kozik, 76, of 13 East Orchard Terrace, Adams, died Friday afternoon, February 6th, at Sweet Brook Care Center, Williamstown. She was born in Magog, Quebec, Canada, on October 1, 1932, the daughter of the late Clarence and Harriet (Goddard) Holt. She first attended schools in Canada, and came to this country at the age of 14, attending local schools, and graduated from the former Adams High School in 1950.
