



James R. Sadlow

August 14, 1946 - December 7, 2009

Mr. James Richard Sadlow, 63, of 12 River Road, Savoy, died Monday evening, December 7, 2009, at Baystate Medical Center in Springfield. He was born in Adams on August 14, 1946, a son of the late Joseph and Josephine (Podziak) Sadlow. He attended Adams schools, and graduated from the former Adams High School in 1964.

He was a US Army Veteran of the Vietnam War, serving overseas in the 863rd Transport Company from 1965 until his Honorable Discharge in 1967.

Mr. Sadlow first worked at General Electric Co. and later, General Dynamics Corp. in Pittsfield, for 31 years, until retiring in 1995.

He had been a communicant of the former Parish of Notre Dame & St. Thomas Aquinas, Adams. He was a member of the Disabled American Veterans, and was a founding member and former vice president of the Savoy Canary Kats Snowmobile Club. He was also a longtime member of the Savoy Volunteer Fire Dept., where he was currently an Honorary Member.

He enjoyed hunting and the outdoors, as well as cruises and trips to Atlantic City.

He is survived by his wife of 43 years, the former Margaret M. Coe, whom he married on August 20, 1966;
